B. Review And Consider The Award Of Magnesium Chloride

Archuleta County accepted bids for the supply and application of Magnesium Chloride to various County Roads. The Contract would be for 2015 with the option to extend the contract in 2016 and 2017 for a total of three years. Desert Mountain Corporation was the low bidder. The total price per gallon to be delivered and applied to Archuleta County various Roads in 2015 is \$0.689. D. Review And Consider Professional Engineering Services For The 2015 Road Plan

In order to complete the 2015 Road Program it will be necessary to retain the services of a consultant to provide the necessary plan, specifications, and bid documents and provide construction administration services. Staff has reviewed the current On-Call list to determine the best available firm. Based upon past experience, familiarity with the project location, and the firm location, staff selected Davis Engineering. Staff requested and received a proposal from Davis Engineering to provide the required services to complete the 2015 Road Program.

Recommended Action:

Award Davis Engineering the contract to provide Professional Engineering Services in an amount Not-To-Exceed \$327,750.00 for the 2015 Road Program.

E. Review And Consider A Detention Center Medical Services Proposal

In March of 2011, Archuleta County awarded a multi-year Medical Services agreement to Pagosa Springs Family Medicine Center. During 2013, the Pagosa Springs Family Medicine Center found it increasingly difficult to provide the services required by the agreement. It was understood at the time that this was because of the illness of a principle of that business. On September 1, 2013, the agreement was assigned to Cornerstone Family Medicine, LLC, with an adjusted Term that allows for automatic "month to month" renewal for one month periods until 30 days notice is provided. That arrangement continues, but the Sheriff's Department determined it was in the best interest of the County to do a new competitive procurement of the service.

Therefore, on January 22, 2015, the County released an RFP (Request for Proposals) for the provision of Medical Services to the Detention Center. Two proposals were received by the Feb. 4th due date, as follows:

\$6,250/Month (Base Fee) - Pagosa Springs Family Medicine Center \$8,333/Month (Base Fee) - Pagosa Springs Medical Center

The existing service provider (Cornerstone Family Medicine) feels that they made a proposal by virtue of sending an email indicating their intention to continue providing services as they have in the past, and at the same rates. However, this form of proposal was specifically excluded from the County's RFP and it has been set aside. Even if it had not been set aside, the Base Fee rate would have been higher than Pagosa Springs Family Medicine Center.

After review of the two "acceptable" proposals (in their entirety, including terms as well as the Base Fee), the Sheriff's Department would like the Commissioners to accept the proposal made by the Pagosa Springs Family Medicine Center, as amended in the attached Notice of Award. Note that the Base Fee of \$6,250 per month will add to \$75,000 over a one year period. The current 2015 annual budget for this service is \$80,000.
